



The results of the 2024 Erasmus grants have been announced.

- 52,550 Euro have been allocated to our university within the scope of **study mobility** and 13,800 Euro within the scope of **internship mobility.** In addition to the allocated amount, 13.700 Euro of our corporate grant amount of 15.600 Euro has transferred to internship mobility, 1.000 Euro to study mobility and the remaining amount to other types of mobility. Payments of students qualified for additional grants (participant with fewer opportunities) included in the relevant amounts are included.
- While distributing the grants, first of all, each department is ranked according to the final score. <u>Click here</u> for Erasmus 2024 placement results.
- After determining the department winners from each department, all winners were ranked according to the highest score. The grant distribution started with the student who got the highest score. The grant is distributed as **four** months for study mobility and **two** months for internship mobility.
- If the student who receives the grant waives his/her right, the grant will first be transferred to the student who have the highest score in the different department, according to the final score ranking in the list of all department winners.
- Students who have received their acceptance letter and will do their internship mobility outside the European Union countries will be able to benefit from 5% of the total grant, and in this context, the two students with the highest scores will be evaluated as grantees. These two students were determined based on the date of submission of their acceptance letter and their final scores. Except for the two students specified, students who want to participate mobility in countries that are not EU members but are included in the project (even if they have won a grant) will have to carry out their mobility without a grant.
- All students with and without grants must sign a **grant agreement** before starting mobility.





- 80% of the grant is deposited before the student goes to Erasmus, and the remaining 20% of the grant is deposited by recalculating their **Attendance Certificate**. The University has the right to request a full refund of the grant invested if a transcript of the mobility and a certificate of participation is not submitted.
- Students who go to Erasmus for education are expected to be successful in at least 80% of the courses they take from the other institution. Istanbul Medipol University has the right to demand the deduction of the remaining 20% grant payment or the refund of the entire grant from the students who failed their courses. If students fail their courses due to **absenteeism**, a deduction will be applied to the amount specified in the grant agreement.
- Students who do not submit an acceptance letter for the internship until November 1,
 2024, will be deemed to have renounced their Erasmus rights.
- Students who have received a grant within the scope of internship mobility but have not submitted an acceptance letter by the deadline (November 1, 2024) will also be deemed to have renounced their Erasmus rights and will be entitled to a grant for students who are substitute starting from the highest score in the explained list.
- <u>In the event that additional grants are allocated</u> to our University for the 2024 project, the grant will be primarily distributed to students who are currently participating Erasmus mobility without a grant, provided that their mobility has not yet been completed.
