- *During the entire double major education, the student's GPA in the major program may drop to 2.50 (65 out of 100) only once. A student whose GPA in the major program falls below 2.72 (70.13 out of 100) for the second time will be deregistered from the second major diploma program. In order for the student to graduate from a double major program, the GPA in the major program must be at least 2.72 (70.13 out of 100).*
